From chamber, world, and family concerts to public policy forums and scientific discovery, Town Hall's season is a present-tense reflection of life on the Puget Sound. With wide-open doors and deeply affordable ticket prices, Town Hall is where our community comes together to be informed and inspired, and to consider the future of our city. 187 events were produced on the Town Hall stage in FY25.
